## Summary

The staff member said that there had been more than 170 donors since the establishment of the donation system in Tianjin in 2003.

Phone Investigation Recording

Investigator: Hello.

Red Cross Employee: Hello, I'm listening.

Investigator: There's a patient, who wants to do an organ transplantation, has heard about

the organ donation. I would like to ask about the situation of organ donation here.

Red Cross Employee: May I ask where you are from?

Investigator: Well, I am, I mean I have a relative from Hulu Island, not far from here, and I am from Guangdong. I just want to know if you have donors. If yes, I will introduce him to come to Tianjin. There is a Central Hospital, which does very well (in terms of organ transplantation), right?

Red Cross Employee: Yes.

Investigator: I just want to know about the situation of organ donation here. I just want to ask how many people have agreed to make donations.

Red Cross Employee: Well...what do you mean? You mean how many people have agreed to make the donation since the establishment of our donation system, right?

Investigator: Yes, yes, yes, how many?

Red Cross Employee: There have been more than 170 people, in Tianjin City.

Investigator: Does this include body donations?

Red Cross Employee: No, the (organ) donors here are all healthy people, they are willing to donate their organs to save patients.

Investigator: When did you begin the organ donation, and how many years did it take to have the more than 100 donors? Since which year?

Red Cross Employee: Since 2003.

Investigator: 2003?

Red Cross Employee: Yes, right.

Investigator: There have been more than 100 donors since the year 2003, right?

Red Cross Employee: Right, right, right...

Investigator: Oh, I see. Are the donors all old or young?

Red Cross Employee: Both, young people are relatively more.

Investigator: Were they sick or (passed away due to) car accidents?

Red Cross Employee: Both. What did you say? They are all healthy voluntary donors.

They come here to get registration and do tissue typing with the patients. That's all.

Investigator: I see. You have more than 100 donors. But a successful donation will only occur after the donor's death, like in a car accident, right? His registration isn't equivalent to having made a successful organ donation. So you mean that there have been more than

100 people, who have registered here since the year 2003, right?

Red Cross Employee: Yes, yes, yes...

Investigator: I see....Those people, who have had the registration, are all doctors and

nurses. I heard that they are doctors and nurses, right?

Red Cross Employee: Oh, no, no.

Investigator: They are not? I see. May I have your director's surname?

Red Cross Employee: Well, where are you from? We are not open to the public.

Investigator: Oh, not open to the public. May I have your last name?

Red Cross Employee: May I ask where you are from?

Investigator: I just want to know about the donation situation, because the donation......
Red Cross Employee: If you want to know about the donation situation, you can come to Shannxi Road in Heping District. You can come over to ask us about this. Our telephone number is only used for the registration of voluntary donors, for communicating regarding this matter.

Investigation: Oh, I see.

mvestigation: On, 1 see.

Red Cross Employee: I'm sorry about this.

Investigator: I would like to talk with your director, I want to know the....

Red Cross Employee: Sorry, our director is in a meeting now.

Investigator: In a meeting? I can talk to him later, what's his telephone number?

Red Cross Employee: Well, it is not public information.
