A female staff member, who answered the phone at the Qinhuangdao Red Cross Society said that they had only one successful case of organ donation, but later she clarified and said that they never had any successful case.

Phone Investigation Recording

Investigator: Is there anyone donating organs for organ transplantation?

Red Cross Worker: Are you talking about successful donation cases or signing the agreement to donate?

Investigator: What do you mean?

Red Cross Worker: Yes, there is.

Investigator: What kind of donation? Someone with cancer?

Red Cross Worker: Organs or corpses?

Investigator: Organs.

Red Cross Worker: If you are talking about organs, we have only one successful case, because the requirements for organ transplantation are pretty high.

Investigator: If a person is dead, can his organs still be used? Are they unusable?

Red Cross Worker: It depends on if it's fit for transplantation, it's up to the No.281

Hospital to decide. For example, kidneys, the hospital would decide if they can be used or not, and the clinicians would make the decision.

Investigator: Body donations?

Red Cross Worker:

Investigator: As you said, there was no donation.

Red Cross Worker: This years with some promotional efforts to raise public awareness, there are some people, who have signed the agreement to donate their organs.

Investigator: Doctors working in hospitals said that there are very few people to donate and very hard to find donors.

Red Cross Worker: Yes, it's the same situation all over the country.

Red Cross Worker: Yes, not so many people did it in the last two years. We have made

lots of efforts in these two years. Signing the donation agreement doesn't mean the donation will be successful. Now some people have signed the agreement, but there is no one, who has actually donated or has made a successful donation.

Investigator: I see, that means signing the agreement to donate and successful donation are two different things.

Red Cross Worker: For example, one person has signed the donation agreement, but he doesn't meet the requirement of actual organ donation, because he is living very well, so how can he donate his organs? He is just willing to do this, and has signed the agreement. Investigator: How many people in your local area have signed?

Red Cross Worker: Who are you? Why do you always want to know about things? These are all secrets! It's not convenient for me to release the information.

Investigator: How is it a secret?

Red Cross Worker: It is a secret.
