## World Organization to Investigate the Persecution of Falun Gong (WOIPFG)

To investigate the criminal conduct of all institutions, organizations, and individuals involved in the persecution of Falun Gong; to bring such investigation, no matter how long it takes, no matter how far and deep we have to search, to full closure; to exercise fundamental principles of humanity; and to restore and uphold justice in society

Mudanjiang City's 610 police Zhu Jiabin Admitted to Harvesting and "Selling" Living Falun Gong Practitioner Gao Yixi's Organs

At 5:22 p.m. on June 21, 2016, when a WOIPFG investigator was investigating and collecting evidence on the case of suspected live organ harvesting and murder of Falun Gong practitioner Gao Yixi in Mudanjiang City, one of the suspects, Zhu Jiabin, the head of the general department of the CCP's "610 Office" in Mudanjiang City, Heilongjiang Province, directly admitted to the investigator his harvesting and "selling" of Falun Gong practitioner Gao Yixi's organs.

## Case Description:

Shortly after 9:00p.m. on April 19, 2016, Falun Gong practitioner Gao Yixi, a 45-year-old male residing in the Water Supplies Bureau Community near Yueya Lake in Mudanjiang City, Heilongjiang Province, was illegally arrested along with his wife Sun Fengxia by five people, led by Mudanjiang Municipal Public Security Xianfeng Sub-Bureau's Yuanming Community Police Office's patrol unit vice-captain Lv Hongfeng and taken to Yuanming Community Police Office. The policemen illegally raided Gao Yixi's home and took away some personal items, including a printer, a laptop and Falun Gong books. After about one hour, Gao Yixi and his wife were sent to the Mudanjiang Second Detention Center to be illegally detained. During his illegal detention, Gao Yixi went on a hunger strike, and he was severely tortured by Yuanming Community Police Office's criminal police team's vice-captain Yu Yang and others. He was later sent to the local public security hospital.

On April 29, at noon time, Gao Yixi's mother and daughter went to the public security hospital to request his release. They were deceived by the people there, who said that Gao was alright, and they were demanded to leave. On April 30, at 10 a.m., his family made a difficult journey to return to their ancestral home. At noon time on the same day, the police went to their ancestral home and found Gao Yixi's elder brother. They told him that Gao Yixi had passed away. And his body was in Mudanjiang Sidao Crematorium's dissecting room. Gao's elder brother rushed to the crematorium, where he was demanded by the police to agree to perform an autopsy on Gao's body and immediately cremate his body afterwards. Since Gao's brother refused to give his consent and yelled at them, they reluctantly agreed to allow Gao's daughter to go to the crematorium. In the end, without his family's consent, the policemen claimed that they had already performed "an autopsy" on his body.

Gao's family had no knowledge of Gao Yixi being taken to the hospital or his autopsy during the entire process. At around 1 p.m. on April 30, Gao Yixi's young daughter, a 16-year-old high school student, rushed to the crematorium. The policemen didn't allow her to see his body, and

there were two special policemen forcefully pulling her arms to prevent her from approaching Gao's body. She saw his body only from two meters away: his eyes were wide open; his stiff arms were stretching out to the right and left; there were obvious handcuff marks on his wrists; and his fists were clenching. His chest and back were swollen and very thick, but his abdomen was particularly flat. In less than two minutes, the special policemen forcibly dragged Gao's daughter out and placed Gao's body in the freezing chamber. His family didn't agree to cremate his body, but the policemen said that his body would be forcibly cremated within three days. In May, upon being pressed by Gao's family's lawyer, the policemen claimed that Gao Yixi died of heart attack. However, Gao Yixi's family and Gao himself have no history of heart diseases. Gao's family had no knowledge of Gao Yixi being taken to the hospital or his autopsy during the entire process. When was an autopsy performed on Gao's body? Why did the autopsy take place? Who carried out the autopsy? And what are the results of the autopsy? His family has no answer for all of these questions.

Zhu Jiabin, the head of the general department of the CCP's "610 Office" in Mudanjiang City, repeatedly admitted in a high-profile way to harvesting and "selling" Gao Yixi's organs. (Download audio file MP3)

Investigator: You carved out his organs, and (you think) you can get away with it? Zhu Jiabin...

Zhu Jiabin: Sold them!

Investigator: Ah?

Zhu Jiabin: All sold, they were all sold.

Investigator: It is ok for you to have sold them, how can you say this so easily? What if Gao Yixi were your brother, would you still talk like this?

Zhu Jiabin: That was just the human stuff. After slaughtering and opening up the belly, you just carve out (the organs), and sell them.

Investigator: Let me tell you, Zhu Jiabin, you are the head of the 610 (office). This is written very clearly on international websites. You know that the 610 at the beginning was Jiang Zemin persecuted Falun Gong...an illegal organization set up to persecute Falun Gong. Your department is illegal and above the law, do you know?

Zhu Jiabin: I do not know.

Investigator: You participated in live organ harvesting of Gao Yixi, and you even said such things. Don't you have a heart (i.e. conscience)? Where is your conscience?

Zhu Jiabin: Yes, I do have. Here it is! I see it is thumping, thumping!

Investigator: You've sold someone else's organs, and you even say something like this?! Are you still human?!

Zhu Jiabin: You even...

Investigator: Humans should have human nature. You are such people without human nature, and you even say such things. If this happened to your family and friends, would you think like this?

Zhu Jiabin: If you appeared in front of me, I would also live organ harvest you, do you believe it or not?

Investigator: You should know that good and evil will be repaid, which is a heavenly principle.

Do you know this principle?

Zhu Jiabin: I don't know. I only know to sell (organs) for money after (organ) harvesting. This is my principle.

Investigator: Let me tell you. Can you bear to spend this money? Ah? If people from your family were live organ harvested and (had their organs) sold by others, could you (bear it)? You!

Zhu Jiabin: Don't you know my nickname?

Investigator: Murderers must pay with their lives, do you know?

Zhu Jiabin: I have just told you. If you had guts to stand in front of me right now, I would live organ harvest you all the same. My nickname is "the butcher".

Investigator: Let me tell you~

Zhu Jiabin: Next time, next time, when you phone me, don't call me by my name. I've changed my name, and I am now called "the butcher".

Investigator: Let me tell you. You persecute Falun Gong, and you've live organ harvested Falun Gong practitioner Gao Yixi. We will track down and hold you responsible for your crimes, do you know?

Zhu Jiabin: Just track me down! I am number one in the world. What do I fear? I am called the butcher, specializing in live organ harvesting!

Investigator: You are so outrageous. You think nobody can punish you, right?

Zhu Jiabin: Who would dare to punish me?

Investigator: The law, are you the law, right? You 610 (Office) is above the law and an illegal organization.

Zhu Jiabin: That I don't know. It was said by you that I am lawless. I feel very good. It's nothing, just like slaughtering pigs. You come over to shave the hair first, and then split open the belly. I would carve out whatever I need. After scoping (the organs) out, I would sell them. How wonderful? How fast the money would come...
